Q Question: May a city or town electric or gas utility terminate electric or gas service during the heating season to a customer who is eligible for and has applied for assistance from the State's Heating Assistance Program?

A.No. IC 8-1-2-121 states that from December 1 through March 15 no electric or gas utility, including a municipally owned utility, shall terminate residential electric or gas service for persons who are eligible and have applied for assistance from a heating assistance program administered under IC 4-4-33.
